What is this product?

TYPE

You invest into a bearer debt obligation of the category Investment Product (Index Certificate), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

TERM

This product has a fixed term until 12/19/2025.

OBJECTIVES

The aim of this product is to provide you with the possibility to gain exposure to the performance of the Underlying. The product has a fixed maturity and reflects the performance of the underlying.

The redemption will depend on the performance of the underlying. The redemption amount at maturity is the equivalent of the price of the underlying multiplied by the multiplier.

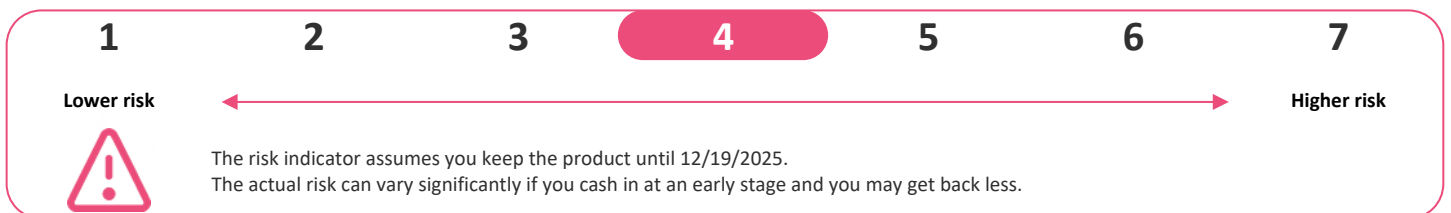

INTENDED RETAIL INVESTOR

What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 4 out of 7, which is a medium risk class.

This rates the potential losses from future performance at a medium level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. COSTS OVER TIME

How long should I hold it and can I take money out early?

Recommended Holding Period: until 12/19/2025

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 12/19/2025 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
