What is this product?

You invest into a debt obligation of the category Leveraged Product (Warrant).

This product has a fixed term until 12/31/2040.

OBJECTIVES

The aim of this product is to benefit from compensation payments when interest rates increase. This has the effect, inter alia, that you are exposed to a very high risk of a total loss of your investment, if interest rates remain constant or move in the opposite direction. The product has a fixed maturity **and represents an option right**. The product represents the right to receive compensation payments. The compensation payments will start at a future point in time. The compensation amount will be paid automatically if the price of the underlying exceeds the base interest rate on the interest determination dates. The compensation amount results from the calculation value and the differential rate as well as the multiplication factor. The differential rate is equal to the price of the underlying less the base interest rate. The multiplication factor decreases towards the maturity date. 
