## What is this product?

### TYPE

You invest into a bearer debt obligation of the category Investment Product (Credit Linked Note), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

### TERM

This product has a fixed term until 7/20/2025.

### OBJECTIVES

The aim of this product is to obtain a higher yield by assuming the default risk of the reference entities. As a result, you assume the credit risk of both the issuer and the reference entities. The product has a rising interest rate and a fixed maturity, unless a credit event occurs.

The interest payments and the redemption amount will depend on the solvency of several reference entities. As long as the solvency of the reference entities is not impaired and no credit event occurs, interest will be paid regularly and the product will be redeemed at the redemption rate at maturity. However, if at least one reference entity is subject to a credit event, the redemption amount as well as the outstanding interest payments will be reduced. Additional credit events related to the other reference entities will lead to further reductions. The redemption amount can be significantly lower than the principal amount. If all reference entities are subject to a credit event, the interest payments and the redemption will be omitted completely and a total loss will occur.

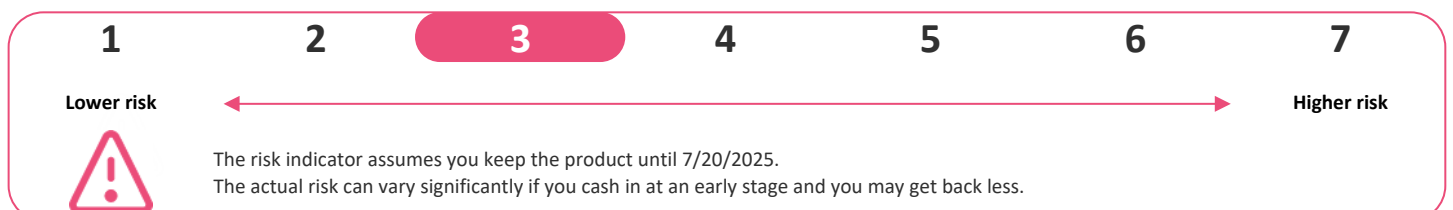

## What are the risks and what could I get in return?

### RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are unlikely to impact our capacity to pay you.

#### COSTS OVER TIME

## How long should I hold it and can I take money out early?

**Recommended Holding Period: until 7/20/2025**

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 7/20/2025 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
