# What is this product?

### ТҮРЕ

You invest into a debt obligation of the category Investment Product (Structured Note).

#### TERM

This product has a fixed term until 2/28/2025.

#### OBJECTIVES

The aim of this product is to provide you with the possibility to gain exposure to the performance of the underlying. The product has a fixed maturity. The redemption will depend on the performance of the underlying. No interest will be paid during the term.

Redemption at maturity will be 100% of the principal amount plus the performance of the underlying multiplied by the participation rate. Performance means the percentage change in the price of the underlying compared to the strike price. Independent of the performance of the underlying, a minimum amount will be paid, which is equivalent to the minimum redemption rate multiplied by the principal amount. The redemption amount is capped at the maximum amount, which is equivalent to the maximum redemption rate multiplied by the principal amount.



# What are the risks and what could I get in return?

#### **RISK INDICATOR**

We have classified this product as 2 out of 7, which is a low risk class.
