**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is this product?

### TYPE

You invest into a bearer debt obligation of the category Investment Product (Capital Protection Note), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

### TERM

This product has a fixed term until 5/31/2026.

### OBJECTIVES

The aim of this product is to benefit from rising prices of the underlying. The product has a fixed maturity. The redemption will depend on the performance of the underlying. No interest will be paid during the term. Redemption at maturity will be the Base Percentage plus the performance of the underlying multiplied by the participation rate. The participation rate determines the interest in the performance of the underlying expressed as a percentage. Performance means the percentage change in the closing price of the underlying compared to the strike price. The redemption amount is capped at the maximum amount, which is equivalent to the maximum redemption rate multiplied by the principal amount. Independent of the performance of the underlying, a minimum amount will be paid, which is equivalent to the minimum redemption rate multiplied by the principal amount.

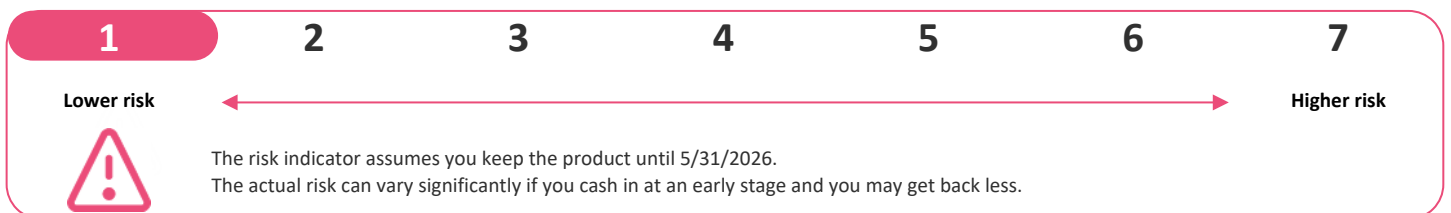
The issuer has an extraordinary right of termination and is entitled to terminate the product early for tax reasons as well as other extraordinary events (e.g. discontinuation of stock exchange listing or calculation of the underlying, impossibility to conduct necessary hedging transactions) at its market value. In this case, the redemption amount may possibly be significantly below the purchase price. ## What are the risks and what could I get in return?

### RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

**Be aware of currency risk.** If the currency of the product is different from the currency of the country in which you live, you will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. You are entitled to receive back at least 100% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain.

**COSTS OVER TIME**

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. We have assumed:

- In the first year you would get back the amount that you invested (0.0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

**How long should I hold it and can I take money out early?**

**Recommended Holding Period: until 5/31/2026**

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 5/31/2026 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
