## What is this product?

### TYPE

You invest into a bearer debt obligation of the category Investment Product (Credit Linked Note), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

### TERM

This product has a fixed term until 1/20/2026.

### OBJECTIVES

The aim of this product is to obtain a higher yield by assuming the default risk of the reference entity. As a result, you assume the credit risk of both the issuer and the reference entity. The product has a fixed interest rate and a fixed maturity, unless a credit event occurs. The interest payments as well as the date and amount of redemption will depend on the solvency of the reference entity. As long as the solvency of the reference entity is not impaired and no credit event occurs, interest will be paid regularly and the product will be redeemed at the redemption rate at maturity. However, if a credit event occurs, no outstanding interest will be paid and the redemption will be omitted either partially or even completely. The redemption amount can be significantly lower than the principal amount and may even be zero. In that case, a total loss will occur. In addition, the maturity will change: depending on the date of the credit event, the product may be redeemed before or after the agreed maturity date. 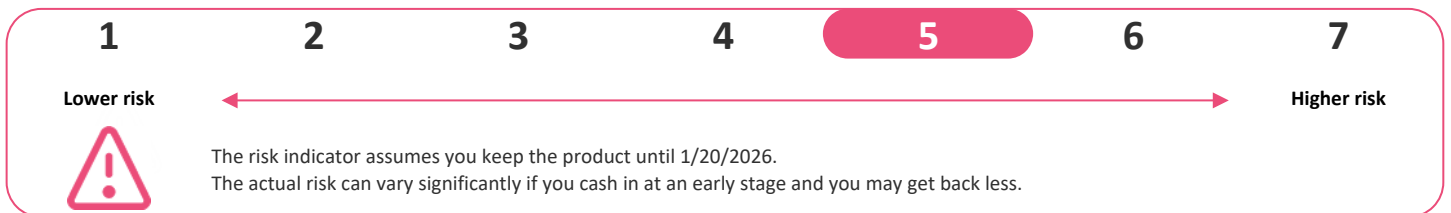
The issuer has an extraordinary right of termination and is entitled to terminate the product early for regulatory and / or tax reasons. ## What are the risks and what could I get in return?

### RISK INDICATOR

### COSTS OVER TIME

- In the first year you would get back the amount that you invested (0.0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

## How long should I hold it and can I take money out early?

**Recommended Holding Period: until 1/20/2026**

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 1/20/2026 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
