You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

TYPE

You invest into a bearer debt obligation of the category Leveraged Product (Knock-out Warrant), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

TERM

This product has no fixed term.

OBJECTIVES

The aim of this product is to provide you with disproportionate (leveraged) participation in rising prices of the Underlying. This has the effect, inter alia, that you are exposed to a very high risk of losing your invested capital if the price of the Underlying moves in the opposite direction. In case of a "knock-out" (immediate expiry), a total loss may occur. The product has no fixed maturity ("open end") and represents an option right.

The participation in the performance of the underlying will be disproportionate through leverage. Leverage results from lower capital employed compared to a direct investment in the underlying. If the price of the underlying reaches or falls below the knock-out barrier, the term will end automatically ("knock-out"). The product will either become worthless or its low residual value will be paid back. The knock-out payout amount will be equivalent to the determined price of the underlying less the strike price; multiplied by the multiplier, and may also be zero.

By exercising the option right, you can demand repayment from the issuer. The redemption amount will be equivalent to the price of the underlying less the strike price; multiplied by the multiplier.

Strike price and knock-out barrier will be adjusted regularly, but at least once a week.

Since futures have a fixed maturity, they will be replaced by an equally structured new contract with a longer term before expiry. This process is called "roll-over". Based on the roll-over costs incurred, the strike price and the knock-out barrier will be adjusted accordingly.

As the underlying is quoted in a currency different from the currency of the product, the conversion into the currency of the product is based on the relevant exchange rate.

The issuer may redeem the product at any time at the respective payout amount, provided it observes a certain period of notice.


The issuer has an extraordinary right of termination and is entitled to terminate the product early for tax reasons as well as other extraordinary events (e.g. discontinuation of stock exchange listing or calculation of the underlying, impossibility to conduct necessary hedging transactions) at its market value. What are the risks and what could I get in return?

RISK INDICATOR





The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class.

This rates the potential losses from future performance at a high level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. How long should I hold it and can I take money out early?



The character of the product does not allow a recommendation regarding to a holding period. For the calculations a holding period of one day is assumed. The product is designed for short term investments since the term ends automatically as soon as the price of the underlying reaches the knock-out barrier. The actual holding period can differ based on market conditions and the leverage of the product. There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product you may get back less than you originally invested. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
