## What is this product?

#### TYPE

You invest into a debt obligation of the category Investment Product (Capital Protection Note).

#### **TERM**

This product has a fixed term until 3/3/2031.

#### OBJECTIVES

The aim of this product is to benefit from rising prices of the underlying. The product has a fixed maturity. No interest will be paid during the term.

The product aims to generate income at the end of the term. The redemption will depend on the performance of the underlying and the following scenarios will be possible:

- o If the closing price of the underlying on the valuation day is equal to or greater than the barrier, repayment will be made at the maximum redemption price.
- o If the closing price of the underlying on the valuation day is equal to or greater than the strike price but lower than the barrier, the product will be redeemed by payment of the base redemption price.
- o If the closing price of the underlying on the valuation day is below the barrier and below the strike price, the capital guarantee applies and the redemption will take place at the minimum redemption price.



### **RISK INDICATOR**
