You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

TYPE

You invest into a debt obligation of the category Investment Product (Capital Protection Note).

TERM

This product has a fixed term until 4/30/2031.

OBJECTIVES

The aim of this product is to benefit from rising prices of the underlying. The product has a fixed maturity. No interest will be paid during the term.

The product aims to generate income at the end of the term. The redemption will depend on the performance of the underlying and the following scenarios will be possible:

- If the closing price of the underlying on the valuation day is equal to or greater than the barrier, repayment will be made at the maximum redemption price.
- If the closing price of the underlying on the valuation day is equal to or greater than the strike price but lower than the barrier, the product will be redeemed by payment of the base redemption price.
- If the closing price of the underlying on the valuation day is below the barrier and below the strike price, the capital guarantee applies and the redemption will take place at the minimum redemption price.

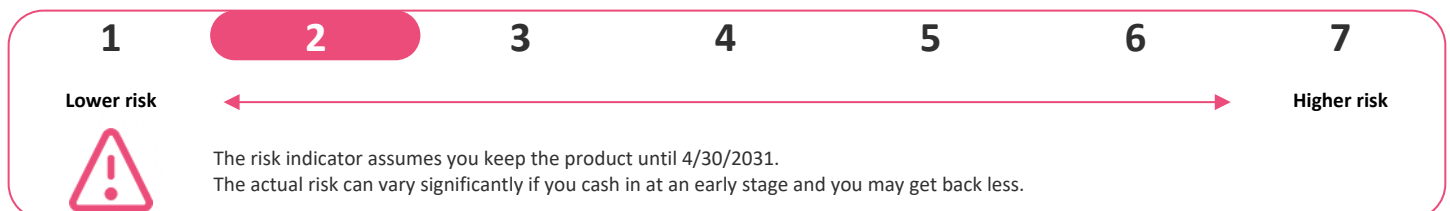
The issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. INTENDED RETAIL INVESTOR

What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. If the currency of the product is different from the currency of the country in which you live, you will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. You are entitled to receive back at least 90% of your capital.
