What is this product?
TYPE
You invest into a debt obligation of the category Investment Product (Express Note).

## TERM

This product has a maturity at the latest on $6 / 30 / 2026$, provided that no early redemption has occurred. Early redemptions are possible on a yearly basis, beginning 6/30/2022.

## OBJECTIVES

The aim of this product is to obtain the highest possible yield by assuming the equity risk and bond risk. The product has a fixed maturity, unless an early redemption occurs. The interest payments as well as the date and amount of redemption will depend on the performance of the underlying. Apart from any payouts provided for in the product terms and conditions, there is no entitlement to other current return (e.g. dividends from the underlying instrument). There is no right to any further entitlement resulting from the underlying (e.g., voting rights). On basis of the previously determined conditions, you take the risk of losing part or all of your invested capital.
If the closing price of the underlying is equal to or exceeds the coupon barrier on a valuation date (five business days before the respective early redemption date), interest will be paid. What are the risks and what could I get in return?
RISK INDICATOR
