# What is this product?

#### TYPE

You invest into a debt obligation of the category Investment Product (Equity Linked Note).

#### **TERM**

This product has a fixed term until 12/1/2024.

#### **OBJECTIVES**

The aim of this product is to obtain the highest possible yield by assuming the equity risk and bond risk. The product has a fixed maturity and the aim is to generate income at the end of the term. No interest will be paid during the term. The redemption will depend on the performance of the underlying. Apart from any payouts provided for in the product terms and conditions, there is no entitlement to other current return (e.g. dividends from the underlying instrument). There is no right to any further entitlement resulting from the underlying (e.g., voting rights). On basis of the previously determined conditions, you take the risk of losing part or all of your invested capital.

At maturity, the product will be redeemed at the redemption rate if the closing price of the underlying is equal to or exceeds the strike price at the valuation date. Otherwise the product will be redeemed by delivering shares of the underlying. The number of delivered shares is equal to the result of dividing the principal amount by the strike price. 
