You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

TYPE

You invest into a bearer debt obligation of the category Investment Product (Worst-of Note), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

TERM

This product has a fixed term until 8/31/2024.

OBJECTIVES

The aim of this product is to obtain the highest possible yield by assuming the equity risk and bond risk. The product has a fixed interest rate and a fixed maturity. The redemption will depend on the performance of the underlyings. Interest is paid independent of the performance of the underlyings. Apart from any payouts provided for in the product terms and conditions, there is no entitlement to other current return (e.g. dividends from the underlying instruments). There are no rights to any further entitlements resulting from the underlyings (e.g., voting rights). On basis of the previously determined conditions, you take the risk of losing part or all of your invested capital.

At maturity, the product will be redeemed at the maximum redemption rate if the closing price of all underlyings remains above the barrier during the observation period. If the closing price of one underlying reaches or falls below the barrier during the observation period and the closing price of all underlyings exceeds the strike price at the valuation date, the product will be redeemed at the maximum redemption rate at maturity. However, if the closing price of at least one underlying is below the strike price at the valuation date, the product will be redeemed at maturity by delivering shares of the underlying with the worst performance ("worst-of"). The number of delivered shares is equal to the result of dividing the principal amount by the strike price. Fractions of shares will not be delivered; a cash settlement amount will be paid instead. The value of the delivered shares will generally be lower than the principal amount.

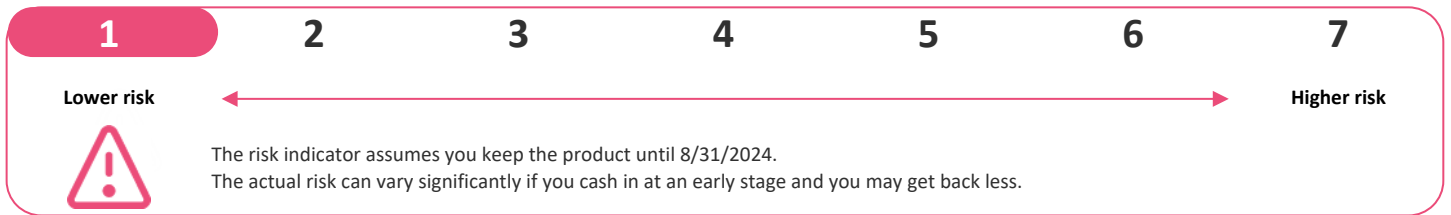

What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

How long should I hold it and can I take money out early?

Recommended Holding Period: until 8/31/2024

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 8/31/2024 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
