You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

TYPE

You invest into a debt obligation of the category Investment Product (Bonus Certificate).

TERM

This product has a fixed term until 12/20/2024.

OBJECTIVES

The aim of this product is to provide you in case of constant or slightly falling prices of the underlying with the possibility of receiving an enhanced return ("bonus"). To achieve this, you take the risk of losing part or all of your invested capital on the basis of the previously determined conditions. The product has a fixed maturity. The redemption will depend on the performance of the underlying. Apart from any payouts provided for in the product terms and conditions, there is no entitlement to other current return (e.g. dividends from the underlying instrument). There is no right to any further entitlement resulting from the underlying (e.g., voting rights). If the price of the underlying remains above the barrier at all times, redemption at maturity will not be less than the bonus amount, which is equivalent to the bonus level multiplied by the multiplier. The redemption is capped at the maximum redemption amount, which is equivalent to the cap multiplied by the multiplier of the underlying is above the bonus level at the end of the term, the product will be redeemed at the maximum redemption amount at maturity. 
