You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

ТҮРЕ

You invest into a bearer debt obligation of the category Leveraged Product (Warrant), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

TERM

This product has a fixed term until 6/21/2024.

OBJECTIVES

The aim of this product is to provide you with disproportionate (leveraged) participation in rising prices of the Underlying. This has the effect, inter alia, that you are exposed to a very high risk of a total loss of your investment in the event of an adverse price movement. The product has a fixed maturity **and represents an option right**. Apart from any payouts provided for in the product terms and conditions, there is no entitlement to other current return (e.g. dividends from the underlying instrument). There is no right to any further entitlement resulting from the underlying (e.g., voting rights).

Leverage results from lower capital employed compared to a direct investment in the underlying. This allows for a disproportionate participation in the performance of the underlying. By exercising the option right, you can demand repayment from the issuer during the term. The redemption amount is positive if the price of the underlying is above the strike price. If the option right has not been exercised, the redemption amount at maturity will be equivalent to the price of the underlying less the strike price, multiplied by the multiplier. If the price of the underlying is equal to or below the strike price at the end of the term, there will be no redemption and a total loss will occur.



RISK INDICATOR

How long should I hold it and can I take money out early?

Recommended Holding Period: until 6/21/2024

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 6/21/2024 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity.
