You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

ТҮРЕ

You invest into a bearer debt obligation of the category Leveraged Product (Warrant), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

TERM

This product has a fixed term until 9/19/2025.

OBJECTIVES

The aim of this product is to provide you with disproportionate (leveraged) participation in rising prices of the Underlying. This has the effect, inter alia, that you are exposed to a very high risk of a total loss of your investment in the event of an adverse price movement. The product has a fixed maturity **and represents an option right**. Apart from any payouts provided for in the product terms and conditions, there is no entitlement to other current return (e.g. dividends from the underlying instrument). There is no right to any further entitlement resulting from the underlying (e.g., voting rights).

Leverage results from lower capital employed compared to a direct investment in the underlying. This allows for a disproportionate participation in the performance of the underlying. 

How long should I hold it and can I take money out early?

Recommended Holding Period: until 9/19/2025
