What is this product?

TVPF

You invest into a debt obligation of the category Convertible Bond. As a trustor, Erste Bank der oesterreichischen Sparkassen AG is liable to the issuer (trustee) for the interest payments and the redemption at maturity.

TERM

This product has a fixed term until 9/1/2024.

OBJECTIVES

The aim of the product is to receive regular interest payments. The product has an initially fixed and then variable interest rate as well as a fixed maturity. The variable interest rate is based on the inflation rate. The inflation rate shows the percentage change in value of the relevant index level compared to the previous year. A minimum interest rate will be paid. Redemption at maturity will be 100% of the nominal amount.

The security can be converted into participation rights on the respective interest payment date.

If you purchase the product during the term, you must pay accrued interest pro rata.



What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the issuer and the trustor are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact the issuer's and trustor's capacity to pay you.

You are entitled to receive back at least 100% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain.
