What is this product?

TYPE

You invest into a debt obligation of the category Convertible Bond. As a trustor, Erste Bank der oesterreichischen Sparkassen AG is liable to the issuer (trustee) for the interest payments and the redemption at maturity.

TERM

This product has a fixed term until 1/7/2027.

OBJECTIVES

The aim of the product is to provide you regular interest payments. The product has a rising return and a fixed maturity. Redemption at maturity will be 100% of the nominal amount.

The security can be converted into participation rights on the respective interest payment date.

If you purchase the product during the term, you must pay accrued interest pro rata.


The issuer is entitled to terminate the product with immediate effect, if an extraordinary tax event occurs. What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because the issuer and the trustor are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are unlikely to impact the issuer's and trustor's capacity to pay you.

You are entitled to receive back at least 100% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain.

However, this protection against future market performance will not apply if you cash-in before maturity.

If the issuer and trustor are not able to pay you what is owed, you could lose your entire investment.

COSTS OVER TIME

- o In the first year you would get back the amount that you invested (0.0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

How long should I hold it and can I take money out early?

Recommended Holding Period: until 1/7/2027
