What is this product?

TYPE

You invest into a debt obligation of the category Convertible Bond. As a trustor, Erste Bank der oesterreichischen Sparkassen AG is liable to the issuer (trustee) for the interest payments and the redemption at maturity.

TERM

This product has a fixed term until 9/6/2034.

OBJECTIVES

The aim of the product is to provide you regular interest payments. The product has a fixed interest rate and a fixed maturity. Redemption at maturity will be 100% of the nominal amount.

The security can be converted into participation rights on the respective interest payment date.

If you purchase the product during the term, you must pay accrued interest pro rata.


The issuer is entitled to terminate the product with immediate effect, if an extraordinary tax event occurs. COSTS OVER TIME
