What is this product?

You invest into a bearer debt obligation of the category Investment Product (Index Certificate), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

TERM

This product has a fixed term until 19/12/2025.

OBJECTIVES

The aim of this product is to provide you with the possibility to gain exposure to the performance of the Underlying. The product has a fixed maturity and reflects the performance of the underlying.

The redemption will depend on the performance of the underlying. The redemption amount at maturity is the equivalent of the price of the underlying multiplied by the multiplier.

How long should I hold it and can I take money out early?

Recommended Holding Period: until 19/12/2025

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 19/12/2025 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity.
