What is this product?

Type

You invest into a debt obligation of the category Investment Product (Index Certificate).

Objectives

The aim of this product is to provide you with the possibility to gain exposure to the performance of the Underlying. The product has a fixed maturity and reflects the performance of the underlying.

The redemption will depend on the performance of the underlying. The redemption amount at maturity will be equivalent to the price of the underlying multiplied by the multiplier.

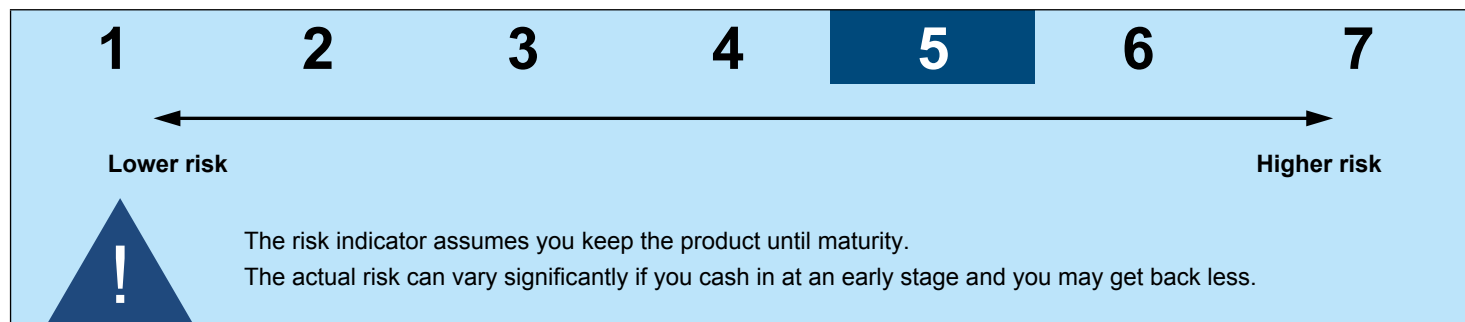
