What is this product?

Type

You invest into a debt obligation of the category Investment Product (Index Certificate).

Objectives

The aim is to benefit from rising prices of the underlying. The product has no fixed maturity (“open-end”) and reflects the performance of the underlying.

The redemption at the respective payout amount can be demanded from the issuer during the term. The payout amount will be equivalent to the price of the underlying multiplied by the multiplier.

The issuer may redeem the product at any time at the respective payout amount, provided it observes a certain period of notice.

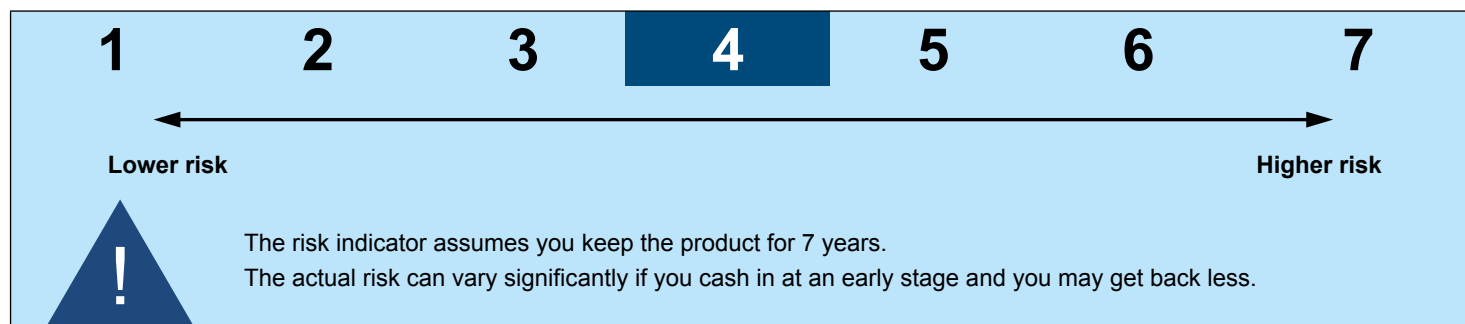
The issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. Examples of extraordinary events include the delisting or loss of the underlying, changes in legislation, tax events and the discontinuation of the issuer's ability to carry out the necessary hedging transactions. In this case, the redemption amount may possibly be significantly below the purchase price.
