# What is this product?

#### TYPE

You invest into a bearer debt obligation of the category Investment Product (Participation Certificate), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

#### TERM

This product has a fixed term until 03/10/2025.

#### **OBJECTIVES**

The aim of this product is to provide you with the possibility to gain exposure to the performance of the Underlying. The product has a fixed maturity and reflects the performance of the underlying.

The redemption will depend on the performance of the underlying. The redemption amount at maturity will be equivalent to the price of the underlying multiplied by the multiplier.

As the underlying is quoted in a currency different from the currency of the product, the conversion into the currency of the product is based on the relevant exchange rate.



# What are the risks and what could I get in return?

### **RISK INDICATOR**

We have classified this product as 4 out of 7, which is a medium risk class.

# How long should I hold it and can I take money out early?

### Recommended Holding Period: until 03/10/2025

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 03/10/2025 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
