You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Investment Product (Participation Certificate).

Objectives

The aim is to benefit from rising prices of the underlying. The product has no fixed maturity (“open-end”) and reflects the performance of the underlying.

The redemption at the respective payout amount can be demanded from the issuer during the term. The payout amount will be equivalent to the price of the underlying multiplied by the multiplier.

As the underlying is quoted in a currency different from the currency of the product, the conversion into the currency of the product is based on the relevant exchange rate.

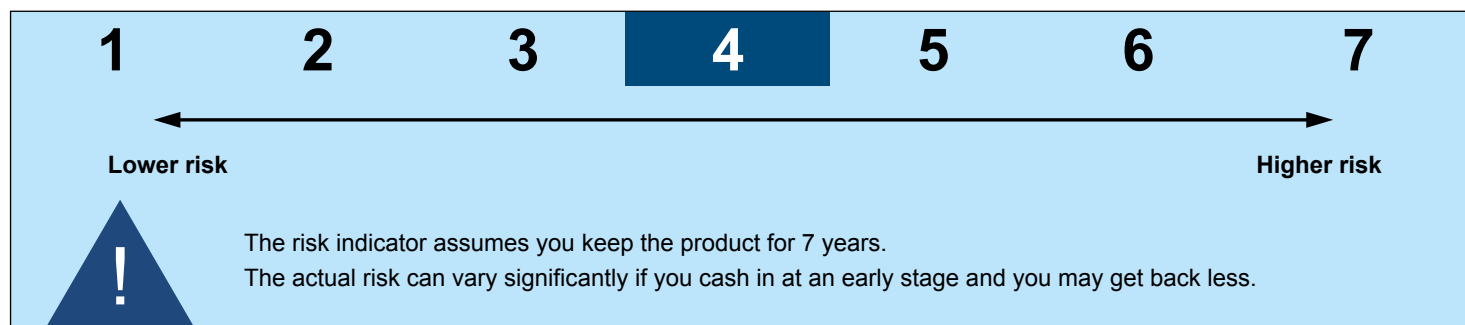
The issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. Examples of extraordinary events include the delisting or loss of the underlying, changes in legislation, tax events and the discontinuation of the issuer's ability to carry out the necessary hedging transactions.
