## What is this product?

### TYPE

You invest into a bearer debt obligation of the category Investment Product (Index Certificate), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

### TERM

This product has no fixed term.

### OBJECTIVES

The aim of this product is to provide you with the possibility to gain exposure to the performance of the Underlying. The product has no fixed maturity ("open-end") and reflects the performance of the underlying.

The redemption at the respective payout amount can be demanded from the issuer during the term. The payout amount is the equivalent of the price of the underlying multiplied by the multiplier.


The issuer has an extraordinary right of termination and is entitled to terminate the product early for tax reasons as well as other extraordinary events (e.g. discontinuation of stock exchange listing or calculation of the underlying, impossibility to conduct necessary hedging transactions) at its market value. In this case, the redemption amount may possibly be significantly below the purchase price. ### INTENDED RETAIL INVESTOR

## What are the risks and what could I get in return?

### RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class.

This rates the potential losses from future performance at a medium-high level, and poor market conditions are very unlikely to impact our capacity to pay you.

### COSTS OVER TIME

## How long should I hold it and can I take money out early?

**Recommended Holding Period: 7 years**
