**You are about to purchase a product that is not simple and may be difficult to understand.**

## What is this product?

### Type

You invest into a debt obligation of the category Investment Product (Express Note).

### Objectives

The aim of this product is to obtain the highest possible yield by assuming the equity risk and bond risk. The product has a fixed maturity, unless an early redemption occurs. The date and amount of redemption will depend on the performance of the underlying. No interest will be paid during the term. On basis of the previously determined conditions, you take the risk of losing part or all of your invested capital.

If the closing price of the underlying is equal to or exceeds the relevant redemption barrier on any valuation date (five business days before the respective early redemption date), the product will be redeemed prior to maturity. The redemption amount will increase by a certain percentage ("rate of increase") with every valuation date. If no early redemption occurs, redemption at maturity will depend on the performance of the underlying. If the closing price of the underlying is equal to or exceeds the final redemption barrier on the last valuation date, the product will be redeemed at the maximum redemption rate. Otherwise the product will be redeemed at an amount, which is equal to the product of the principal amount and the performance of the underlying. The performance of the underlying is equal to the result of dividing the closing price of the underlying on the last valuation date by the strike price.

This product has a latest maturity date on 9/29/2021, provided that no early redemption has occurred. Early redemptions are possible on a yearly basis, beginning 9/29/2018.

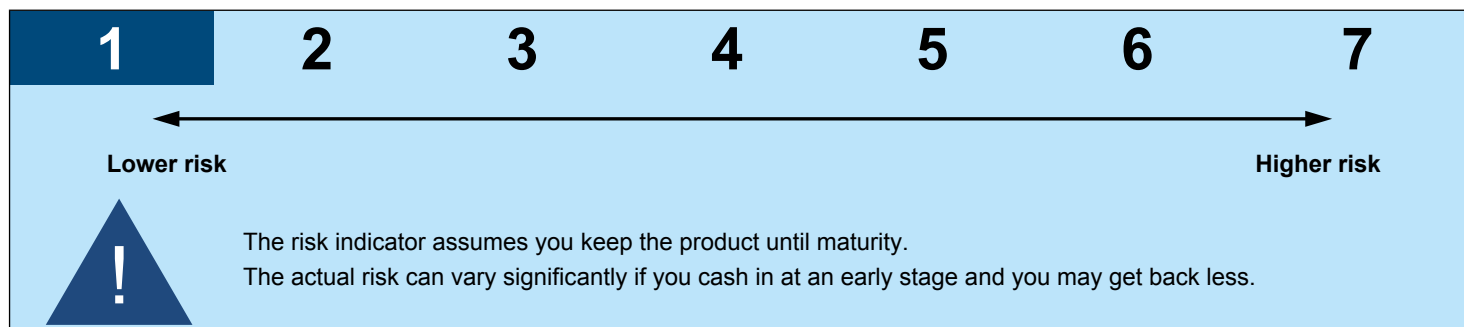
The issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. ### Intended retail investor

## What are the risks and what could I get in return?

### Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

**Be aware of currency risk.** If the currency of the product is different from the currency of the country in which you live, you will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies.
