You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Investment Product (Structured Note).

Objectives

The aim is to benefit from rising prices of the underlying. The product has a fixed maturity. The redemption will depend on the average performance of the underlying. No interest will be paid during the term.

Redemption at maturity will be 100% of the principal amount plus the performance of the underlying multiplied by the participation rate. Performance means the average percentage change in the price of the underlying compared to the strike price. Independent of the performance of the underlying, a minimum amount will be paid, which is equivalent to the minimum redemption rate multiplied by the principal amount. The redemption amount is capped at the maximum amount, which is equivalent to the maximum redemption rate multiplied by the principal amount.

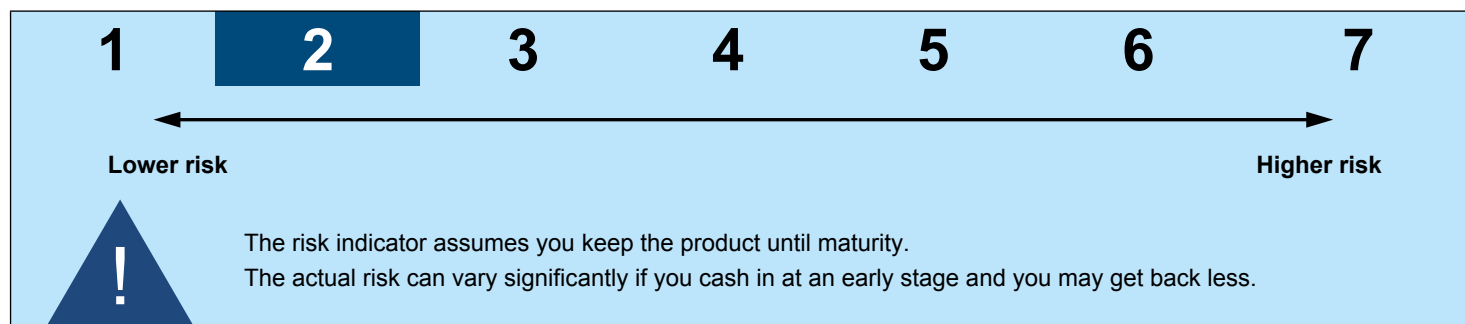

Risk Indicator

We have classified this product as 2 out of 7, which is a low risk class.
