You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Leveraged Product (Warrant).

Objectives

The aim is to disproportionately benefit from falling prices of the underlying through leverage. In return, there is a disproportionate risk of loss if the price of the underlying is developing contrary to the expectations. The product has a fixed maturity and represents an option right. There is no entitlement to other regular income (e.g. dividends of the underlying).

Leverage results from lower capital employed compared to a direct investment in the underlying. This allows for a disproportionate participation in the performance of the underlying. By exercising the option right, the redemption can be demanded from the issuer during the term. The redemption amount is positive if the price of the underlying is below the strike price. If the option right has not been exercised, the redemption amount at maturity will be equivalent to the strike price less the price of the underlying, multiplied by the multiplier. If the price of the underlying is equal to or above the strike price at the end of the term, there will be no redemption and a total loss will occur.

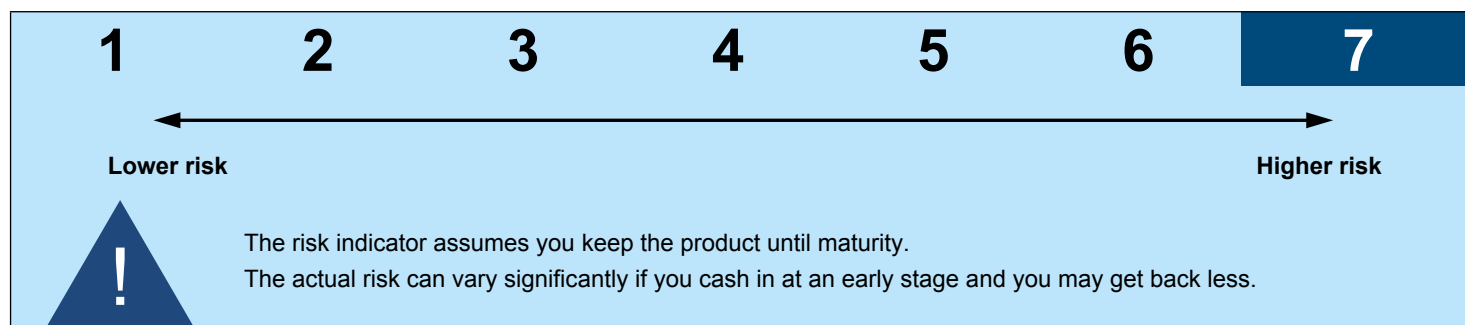
