You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Investment Product (Equity Linked Note).

Objectives

The aim is to obtain the highest possible yield by assuming the equity risk and bond risk. The product has a fixed interest rate and a fixed maturity. The redemption will depend on the performance of the underlyings. Interest is paid independent of the performance of the underlyings. There is no entitlement to other regular income (e.g. dividends of the underlyings).

At maturity, the product will be redeemed at the maximum redemption rate if the closing price of all underlyings remains above the barrier during the observation period. If the price of at least one underlying reaches or falls below the barrier during the observation period, the product will be redeemed at maturity according to the performance of the underlying with the worst performance; capped at the redemption rate. The performance of the underlying is equal to the result of dividing the closing price of the underlying on the valuation date by the strike price.

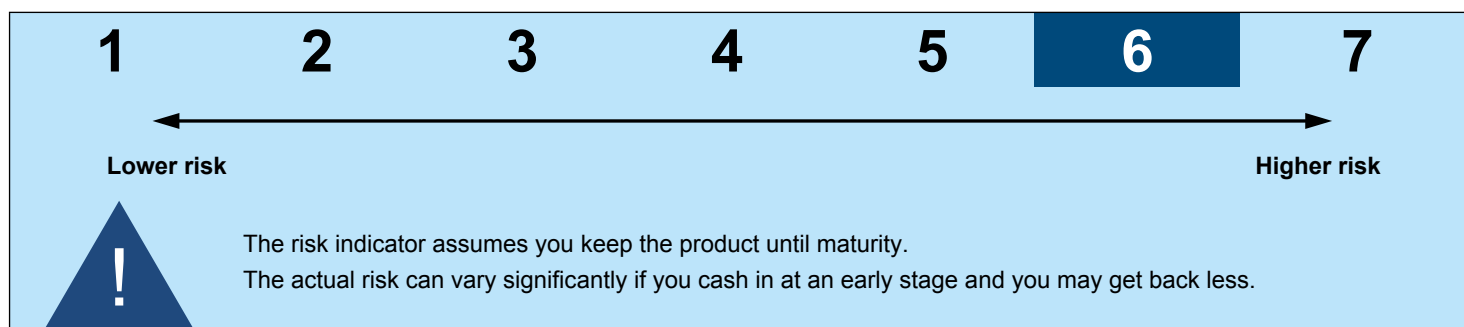

Risk Indicator
