You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Investment Product (Capital Protection Note).

Objectives

The aim is to benefit from rising prices of the underlying. The product has a fixed maturity. The redemption will depend on the average performance of the underlying. No interest will be paid during the term.

Redemption at maturity will be the base rate plus the performance of the underlying multiplied by the participation rate. The participation rate determines the interest in the performance of the underlying expressed as a percentage. Performance means the percentage change in the averaged final price of the underlying of all valuation days during the relevant observation period compared to the strike price. The redemption amount is capped at the maximum amount, which is equivalent to the maximum redemption rate multiplied by the principal amount. Independent of the performance of the underlying, a minimum amount will be paid, which is equivalent to the minimum redemption rate multiplied by the principal amount.

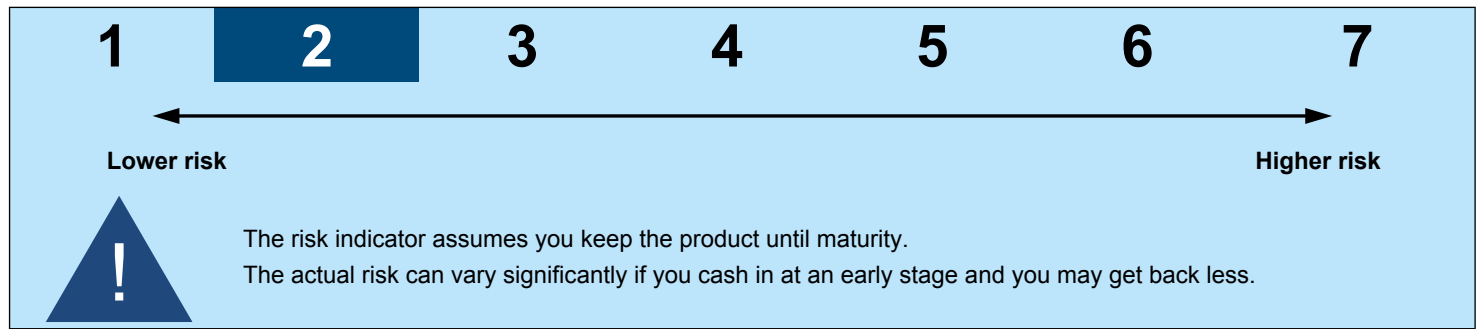
The issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. What are the risks and what could I get in return?

Risk Indicator

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain.

However, this protection against future market performance will not apply if you cash-in before maturity.
