You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Investment Product (Equity Linked Note).

Objectives

The aim is to obtain the highest possible yield by assuming the equity risk and bond risk. The product has a fixed interest rate and a fixed maturity. The redemption will depend on the performance of the underlying. Interest is paid independent of the performance of the underlying. There is no entitlement to other regular income (e.g. dividends of the underlying).

At maturity, the product will be redeemed at the redemption rate if the closing price of the underlying is equal to or exceeds the barrier at the valuation date. Otherwise the product will be redeemed by delivering shares of the underlying. The number of delivered shares is equal to the result of dividing the principal amount by the strike price. Fractions of shares will not be delivered; a cash settlement amount will be paid instead. The value of the delivered shares will generally lower than the principal amount.

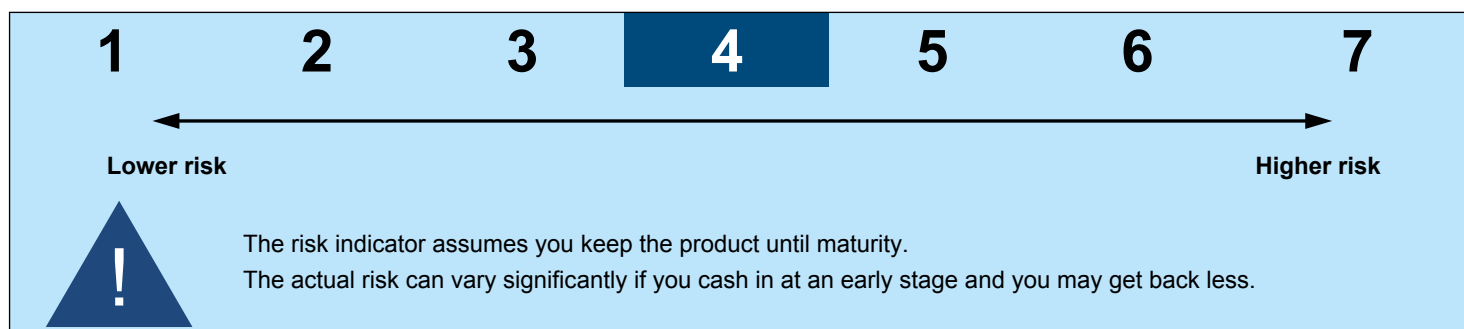
