You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Leveraged Product (Warrant).

Term

This product has a fixed term until 12/31/2035.

Objectives

The aim of this product is to benefit from compensation payments when interest rates increase. This has the effect, inter alia, that you are exposed to a very high risk of a total loss of your investment, if interest rates remain constant or move in the opposite direction. The product has a fixed maturity and represents an option right.

The product represents the right to receive compensation payments. The compensation amount will be paid automatically if the price of the underlying exceeds the base interest rate on the interest determination dates. The compensation amount results from the calculation value and the differential rate as well as the multiplication factor. The differential rate is equal to the price of the underlying less the base interest rate. The multiplication factor decreases towards the maturity date. For the complete redemption plan, please see the Final Terms. If the price of the underlying is equal to or below the base interest rate at all times, there will be no compensation payments and a total loss will occur.

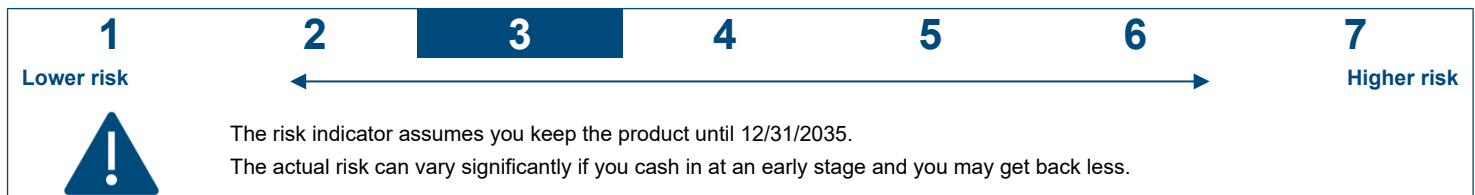
The issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. Examples of extraordinary events include the delisting or loss of the underlying, changes in legislation, tax events and the discontinuation of the issuer's ability to carry out the necessary hedging transactions. What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk.
