## What is this product?

### TYPE

You invest into a bearer debt obligation of the category Leveraged Product (Warrant), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

### TERM

This product has a fixed term until 29/12/2045.

### OBJECTIVES

The aim of this product is to benefit from compensation payments when interest rates increase. This has the effect, inter alia, that you are exposed to a very high risk of a total loss of your investment, if interest rates remain constant or move in the opposite direction. The product has a fixed maturity and represents an option right. The product represents the right to receive compensation payments. The compensation amount will be paid automatically if the price of the underlying exceeds the base interest rate on the interest determination dates. The compensation amount results from the calculation value and the differential rate as well as the multiplication factor. The differential rate is equal to the price of the underlying less the base interest rate. The multiplication factor decreases towards the maturity date. If the price of the underlying is equal to or below the base interest rate at all times, there will be no compensation payments and a total loss will occur.

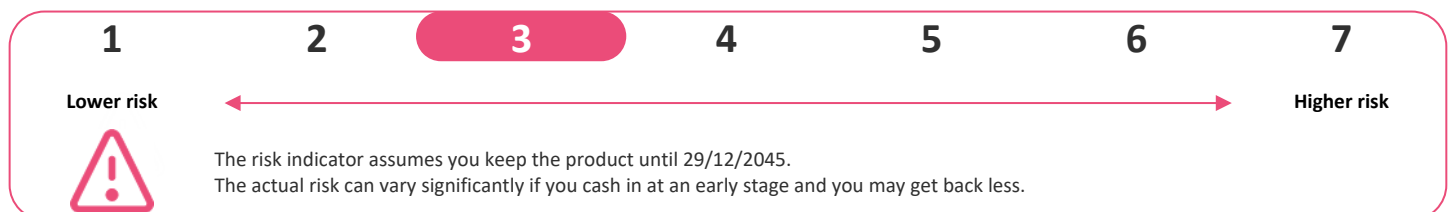
The issuer has an extraordinary right of termination and is entitled to terminate the product early for tax reasons as well as other extraordinary events (e.g. discontinuation of stock exchange listing or calculation of the underlying, impossibility to conduct necessary hedging transactions) at its market value. ## What are the risks and what could I get in return?

### RISK INDICATOR

### COSTS OVER TIME

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. ## How long should I hold it and can I take money out early?

**Recommended Holding Period: until 29/12/2045**

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 29/12/2045 (Maturity Date). There is no other way to withdraw your money early than to sell the product over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
