You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Investment Product (Capital Protection Note).

Objectives

The aim is to benefit from rising prices of the underlying. The product has a fixed maturity. No interest will be paid during the term.

The product aims to generate income at the end of the term. The redemption will depend on the performance of the underlying and the following scenarios will be possible:

- If the closing price of the underlying on the valuation day is equal to or greater than the barrier, repayment will be made at the maximum redemption price.
- If the closing price of the underlying on the valuation day is equal to or greater than the strike price but lower than the barrier, the product will be redeemed by payment of the base redemption price.
- If the closing price of the underlying on the valuation day is below the barrier and below the strike price, the capital guarantee applies and the redemption will take place at the minimum redemption price.

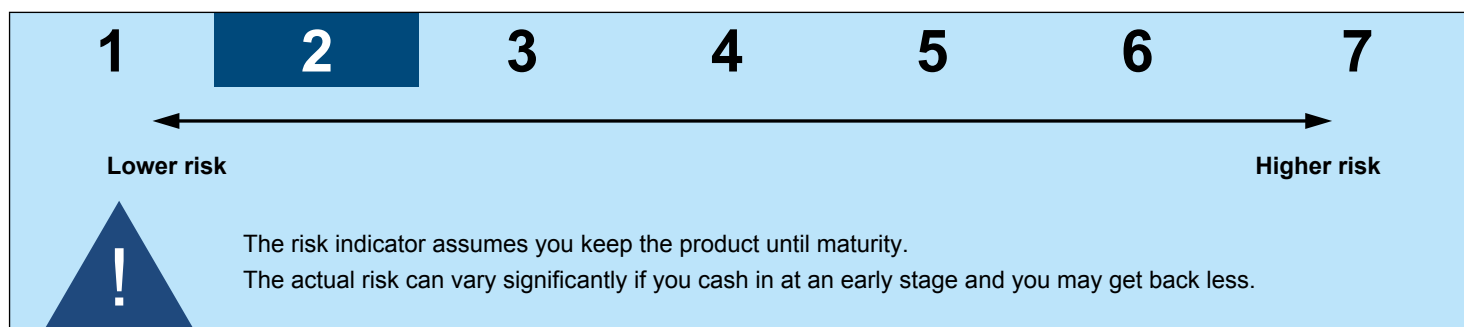
The issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. Examples of extraordinary events include the delisting or loss of the underlying, changes in legislation, tax events and the discontinuation of the issuer's ability to carry out the necessary hedging transactions. In this case, the redemption amount (fair market price) may possibly be significantly below the purchase price. Intended retail investor

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 90% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain.

However, this protection against future market performance will not apply if you cash-in before maturity.
