This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

TYPE

You invest into a debt obligation of the category Leveraged Product (Knock-out Warrant).

TERM

This product has a fixed term until 11/30/2023.

OBJECTIVES

The aim of this product is to provide you with disproportionate (leveraged) participation in falling prices of the Underlying. This has the effect, inter alia, that you are exposed to a very high risk of losing your invested capital if the price of the Underlying moves in the opposite direction. In case of a “knock-out” (immediate expiry), a total loss may occur. The product has a fixed maturity and represents an option right.

The participation in the performance of the underlying will be disproportionate through leverage. Leverage results from lower capital employed compared to a direct investment in the underlying. If the price of the underlying reaches or exceeds the knock-out barrier, the term will end automatically („knock-out“). The product will either become worthless or its low residual value will be paid back. The knock-out payout amount will be equivalent to the strike price less the determined price of the underlying; multiplied by the multiplier, and may also be zero.

By exercising the option right, you can demand repayment from the issuer during the term. The redemption amount is positive if the price of the underlying is below the strike price. If the option right has not been exercised, the redemption amount at maturity will be equivalent to the strike price less the price of the underlying, multiplied by the multiplier. If the price of the underlying is equal to or above the strike price at the end of the term, there will be no redemption and a total loss will occur.

Since futures have a fixed maturity, they will be replaced by an equally structured new contract with a longer term before expiry. This process is called “roll-over”.

Based on the roll-over costs incurred, the strike price and the knock-out barrier will be adjusted accordingly.

As the underlying is quoted in a currency different from the currency of the product, the conversion into the currency of the product is based on the relevant exchange rate.

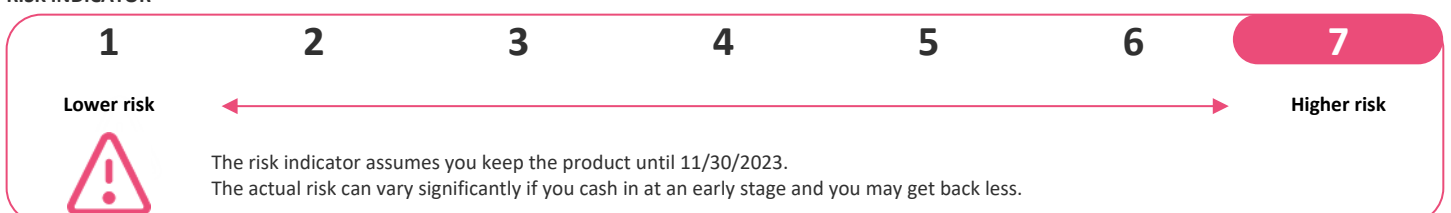

What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 7 out of 7, which is the highest risk class.

This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. If the currency of the product is different from the currency of the country in which you live, you will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

How long should I hold it and can I take money out early?

Recommended Holding Period: until 11/30/2023

The character of the product does not allow a recommendation regarding a holding period. For the calculations of the parameters of this document a holding period until maturity is assumed. The product is designed for short term investments since the term ends automatically as soon as the price of the underlying reaches the knock-out barrier. The actual holding period can differ based on market conditions and the leverage of the product. The price is subject to fluctuations during the life of the product, which may result in losses. During the respective trading hours the product can be sold on each stock exchange where the product is listed.
