# What is this product?

#### TYPE

You invest into a bearer debt obligation of the category Investment Product (Index Certificate), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

#### TERM

This product has no fixed term.

#### **OBJECTIVES**

The aim of this product is to provide you with the possibility to gain exposure to the performance of the Underlying. The product has no fixed maturity ("open-end") and reflects the performance of the underlying.

The redemption at the respective payout amount can be demanded from the issuer during the term. The payout amount is the equivalent of the price of the underlying multiplied by the multiplier and the Management Factor. The Management Factor corresponds to the term-dependent conversion of the Management Fee.

In this case, the redemption amount may possibly be significantly below the purchase price. ### RISK INDICATOR

We have classified this product as 5 out of 7, which is a medium-high risk class.

### How long should I hold it and can I take money out early?

### **Recommended Holding Period: 7 years**

The product is designed for a long term investment. The actual holding period can differ based on market conditions. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary.
