You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

TYPE

You invest into a bearer debt obligation of the category Investment Product (Capital Protection Note), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

TERM

This product has a fixed term until 13/04/2026.

OBJECTIVES

The aim of this product is to benefit from rising prices of the underlying. The product has a fixed maturity. The redemption will depend on the average performance of the underlying. No interest will be paid during the term. Redemption at maturity will be the Base Percentage plus the performance of the underlying multiplied by the participation rate. The participation rate determines the interest in the performance of the underlying expressed as a percentage. Performance means the percentage change in the averaged final price of the underlying of all valuation days during the relevant observation period compared to the strike price. The redemption amount is capped at the maximum amount, which is equivalent to the maximum redemption rate multiplied by the principal amount. Independent of the performance of the underlying, a minimum amount will be paid, which is equivalent to the minimum redemption rate multiplied by the principal amount.

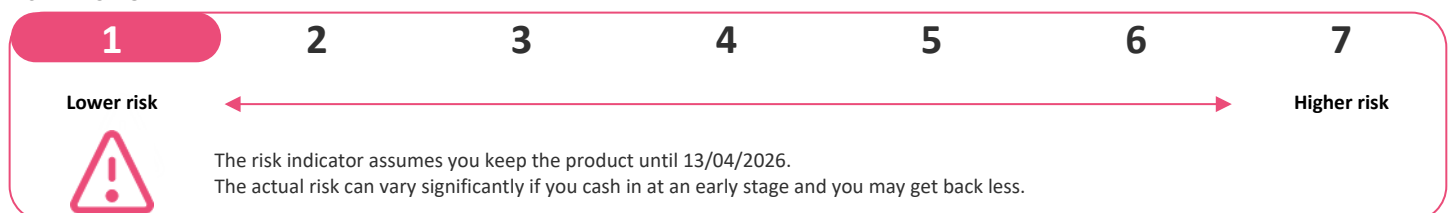

This product is targeted for retail investors who emphasize a full capital protection and prefer a short-term investment horizon. The retail investor has sufficient knowledge and/or experience with financial products. The retail investor puts emphasis on capital growth.

What are the risks and what could I get in return?

RISK INDICATOR



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 1 out of 7, which is the lowest risk class.

This rates the potential losses from future performance at a very low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. If the currency of the product is different from the currency of the country in which you live, you will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above. You are entitled to receive back at least 108% of your capital. Any amount over this, and any additional return, depends on future market performance and is uncertain.

How long should I hold it and can I take money out early?

Recommended Holding Period: until 13/04/2026

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 13/04/2026 (Maturity Date). There is no other way to withdraw your money early than to sell the product over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
