# What is this product?

#### TYPE

You invest into a bearer debt obligation of the category Investment Product (Structured Note), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

#### **TERM**

This product has a fixed term until 21/10/2029.

#### **OBJECTIVES**

The aim of this product is to receive regular interest payments and to benefit from a rising inflation rate. The product has a variable interest rate and a fixed maturity. The variable interest rate is based on the inflation rate. The inflation rate shows the percentage change in value of the relevant index level compared to the previous year. A minimum interest rate will be paid. Redemption at maturity will be 100% of the nominal amount.



# Recommended Holding Period: until 21/10/2029

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 21/10/2029 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter. No fees or penalties will be charged by the Issuer for such a transaction, but an execution fee may be charged by your intermediary. If you sell the product before it matures you may get back less than if you had held the product until maturity. In case of exceptional market situations or technical disruptions, it may be temporarily difficult or impossible to buy or sell the product.
