What is this product?

Type

You invest into a debt obligation of the category Investment Product (Structured Note).

Term

This product has a fixed term until 10/21/2029.

Objectives

The aim of this product is to receive regular interest payments and to benefit from a rising inflation rate. The product has a variable interest rate and a fixed maturity. The variable interest rate is based on the inflation rate. The inflation rate shows the percentage change in value of the relevant index level compared to the previous year. A minimum interest rate will be paid. Redemption at maturity will be 100% of the nominal amount.

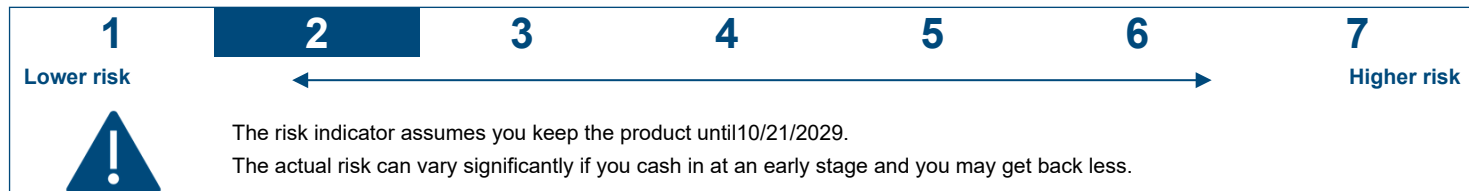
The issuer is entitled to terminate the product with immediate effect, if an extraordinary event occurs. Examples of extraordinary events include changes in legislation and tax events. What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class.

This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. If the currency of the product is different from the currency of the country in which you live, you will receive payments in a different currency, so the final return you will get will depend on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.
