You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type

You invest into a debt obligation of the category Investment Product (Equity Linked Note).

Term

This product has a fixed term until 12/1/2024.

Objectives

The aim of this product is to obtain the highest possible yield by assuming the equity risk and bond risk. The product has a fixed maturity and the aim is to generate income at the end of the term. No interest will be paid during the term. The redemption will depend on the performance of the underlying. Apart from any payouts provided for in the product terms and conditions, there is no entitlement to other current return (e.g. dividends from the underlying instrument). On basis of the previously determined conditions, you take the risk of losing part or all of your invested capital.

At maturity, the product will be redeemed at the redemption rate if the closing price of the underlying is equal to or exceeds the strike price at the valuation date. Otherwise the product will be redeemed by delivering shares of the underlying. The number of delivered shares is equal to the result of dividing the principal amount by the strike price. Fractions of shares will not be delivered; a cash settlement amount will be paid instead. The value of the delivered shares will generally be lower than the principal amount.

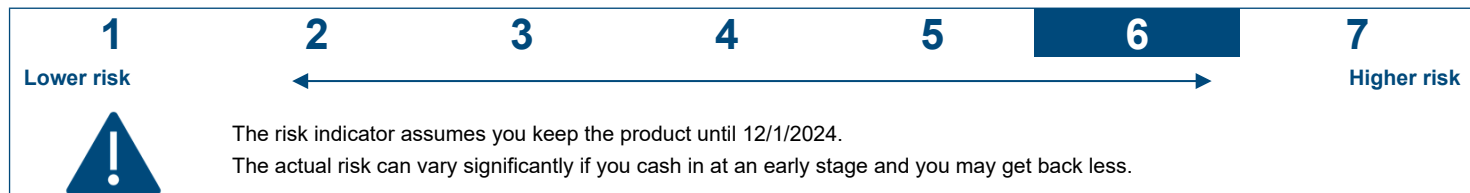

What are the risks and what could I get in return?

Risk Indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 6 out of 7, which is the second-highest risk class.

This rates the potential losses from future performance at a high level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk.
