You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

You invest into a bearer debt obligation of the category Investment Product (Bonus Certificate), which is subject to Austrian law and entitles the respective holder to receive amounts due from us as issuer.

TERM

This product has a fixed term until 12/20/2024.

OBJECTIVES

The aim of this product is to provide you in case of constant or slightly falling prices of the underlying with the possibility of receiving an enhanced return ("bonus"). To achieve this, you take the risk of losing part or all of your invested capital on the basis of the previously determined conditions. The product has a fixed maturity. The redemption will depend on the performance of the underlying. Apart from any payouts provided for in the product terms and conditions, there is no entitlement to other current return (e.g. dividends from the underlying instrument). There is no right to any further entitlement resulting from the underlying (e.g., voting rights). How long should I hold it and can I take money out early?

Recommended Holding Period: until 12/20/2024

The product aims to generate the return described above under "What is this product?". However, only if it is held until maturity. It is therefore recommended that you hold the product until 12/20/2024 (Maturity Date). There is no other way to withdraw your money early than to sell the product via the exchange on which it is listed or over-the-counter.
