## What is this product?

### Type

You invest into a subordinated debt obligation of the category Investment Product (Structured Note).

### Objectives

The aim is to receive regular interest payments and to benefit from rising interest rates. The product has an initially fixed and then variable interest rate as well as a fixed maturity. The variable interest rate is based on the reference interest rate. A minimum interest rate will be paid. The variable interest rate is capped at the maximum interest rate. Redemption at maturity will be 100% of the principal amount.

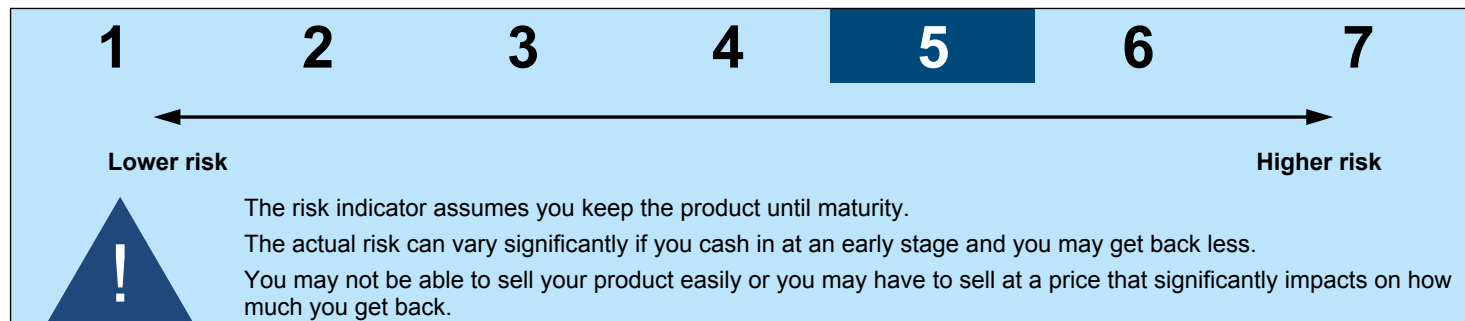

### Risk Indicator

### What are the costs?
